YOUR CALIFORNIA PRIVACY RIGHTS

- Education information; which includes education history and languages spoken;
- <u>Information not listed above and related to characteristics protected under California or federal law;</u> which includes date of birth; gender; marital status; and/or military service/veteran status;
- Other personal information not listed above and described in California Civil Code § 1798.80(e), which includes bank account number, routing number, credit card number and associated CVV2, expiration date, credit history, report, and score; insurance certificate number; ; property value; tax information; signature; physical characteristics or description; and/or insurance policy number.

- Information that is publicly available online or elsewhere.
